Conditions of Entry

All competitors must have a current Sprintcar Control Council of Australia Competition licence_all Sprintcars are to be SCCA registered, racing is conducted as per the current SCCA Racing Rules, Regulations and Specifications. Competitor will be required to have a current and valid **Speedway Australia Licence card**.

Noise Level 95 dba. Effective type mufflers must be used (Sprintcars with any straight through mufflers will not be started under any circumstances)

All Speedway Australia OH&S Pit rules and safety conditions apply at all times. PROGRAM
1. Serutingering Starter 2.00pm
2. Serutingering Ender 4.00pm

Scrutineering Starts: 2.00pm
 Driver Sign In: 3.30pm

2. Scrutineering Ends: 4.00pm4. Drivers Briefing: 4.30pm

Engine Starts, Hot laps, Time Trials and Race times will be notified at the driver briefing. Note the venues in consiltaion with the SRA reserve the right to conducted hot laps at their discretion.

Driver Briefing - All drivers must attend the compulsory drivers meeting.

Any Driver not attending the driver briefing will have one lap at the end of their time trials group with a best possible time of one position less than 50%)

Sign in Time: Drivers must sign in by 3.30pm so they can be draw into their respective time trial groups. Driver only can nominate. Any competitors not nominated by the 3.30pm deadline will only receive 1 timed lap at the end of their group and cannot qualify can qualify any higher than 8th position in there qualifying group.

Format to be as follows:

Drivers to sign in by 3.30pm and do their draw for their time trial group. Drivers will randomly draw for their Time Trial group / heat race or (Races). Drivers drawn for positions one and two in each Time Trial/Heat group will then be paired together for two car two lap qualify as will the drivers drawn as positions three and four and so on.

This would be three time that group of 10 and one of 9 cars.

Time Trial Group Qualify

<u>The number of Time Trial / Heat groups will be determined by the number of cars attending.</u>

FORMATS:

Any Driver that cannot take their drawn position in Time Trial events may have one lap at the end of their time trials group with a best possible time of one position less than 50%) The car must be able to complete this qualifying under its own power.

Time Trial Qualifying and One Heat Format.

Drivers random draw into heats and Time Trial order draw, 2 laps by two cars at a time.

(Maximum 13 cars per qualifying session) You Time Trail against drivers in your heat.

The One heat format will use – an invert of (6) based on Qualifying times.

<u>TIED POINTS</u> –- One and Two heat formats – All time trial times will be merged. In the event of a tie-on points, the driver that has recorded the fastest lap time

during time trials will be deemed to be the higher qualifier in the Main events. (Or Shootouts if conducted)

• Time Trial Qualifying and Two Heat Format.

Drivers random drawn into heats and Time Trial order draw, 2 laps by two cars at a time.

(Maximum 13 cars per qualifying session) You Time Trail against drivers in your heat.

Time Trial Qualifying, Fast time to P1 in your heat, 2nd fastest to P2 and so on. The second round of heats will be inverted subject to heat cars counts.

<u>Heat races with 7 or 8 sprintcar will have a 6-car inversion.</u> Heat races with 9 or 10 sprintcar will have a 8-car inversion.

Heat races with 11 or12 sprintcar will have a 10-car inversion.

Each driver will have an inside row start and an outside row start. Points obtained through the drawn Heat Time Trial Qualifying will have the same points for qualifying as heats that will determine the qualifying position in the C, B and A Mains.

Top 8 points qualifiers – <u>for both the Time Trial and Normal formats.</u>

• **Shootout One** will be for points qualifiers 5th to 8th, X three laps, the two fastest drivers stay on track and will be joined by the 3rd and 4th Qualifiers for **Shootout Two** X3 three laps. **Shootout Three** the two fastest drivers stay on track and will be joined by the 1st and 2nd Qualifiers.

• Finishing positions on best times in the Time trial shootouts will be the starting positions in the A-Main, Positions 1 to 8. (Fast time driver, will have choice of P1 or P2).

• If the top 8 Shootout cannot be run the starting grids will be formed from qualifying points.

• FORMAT – No Time Trials.

- Each driver to compete in 2 heat races of ten laps.
- 1st round of heats grids will be set by driver's random draw at start of night.
- 2nd round of heats inverted and changing to a different heat.
- Drivers not up to speed on the night may be requested to start at the rear of their second heat. (Stewards discretion)
- Each driver will have an inside row start and an outside row start, in the heats.
- Points attained through heats to determine qualifying position in A, B or C-Mains
- If you do not finish your heat, you do not get any heat points.
- In the event of tied points in this format all heat times will be merged, the driver that has recorded the fastest lap time during the heats will be deemed to be the higher qualifier in the Main events. (Or Shootouts if conducted)

Main Events

(20 car A Main 30 Laps) Grid 1st to 8th as per the Shootout, 9th to 14th on qualifying points plus the top 6 from the B Main.

(18 car B Main 15 Laps) Grid 15th to 28th plus the top 4 from the C Main. 4 cars transfer from C Main through to the back of the B-Main.

(18 car C Main 10 Laps) Grid 29th to 46th.

Heat Races will be over 10 laps.

TRANSPONDER RACING - All Sprintcars competing in this will be required to be fitted with an AMB Transponder for the purpose of lap scoring and timing.

<u>The Venue operators in consultation with their State Member Club reserves</u> to right to alter the format if required.





MEETING CANCELLATION – <u>Rain Out or cancellation of an event due to unforeseen circumstances</u> Clause:

If a race meeting is cancelled prior to 5pm on race day, no monies are payable from the promoter/venue operator to the SRA. Nomination fees received from drivers for that event will be refunded. If the race meeting is cancelled between 5pm and the first race, 12% of the prize money is payable from the promoter/venue operator to the SRA. Rainout passes are then usually issued to everyone by the track. If the race meeting is cancelled after the 6th event and no pass outs are issued, then the full event fee plus GST is payable from the promoter/venue operator to the SRA. If the meeting is cancelled after the sixth event and pass outs are handed out, then 60% of the prize money plus GST is payable from the promoter/venue operators to the SRA. If a B-Main has started and the meeting is cancelled, then the full amount of the prize money plus GST is payable. In the preceding circumstances, the SRA will firstly deduct any incurred expenses, and the remaining amount will be divided equally amongst the drivers attending. In the event of the A-main starting, but the race cannot be completed, then SCCA rule 6-16 "race distance" parts 1 and 2 shall apply.
