## SRA 2009-2010 360 VICTORIAN SPRINTCAR STATE TITLE

### *Simpson Speedway Simpson- 6<sup>th</sup> February 2010*

**This event is open only to current SCCA registered 360ci Sprintcars as per the 360 Sprintcar specifications.**

The Event will take place under the SCCA racing rules, regulations and specifications as set out in the current rulebook.

### **FORMAT**

- Each driver to compete in two heat races of ten laps.
- First round of heats to be drawn at the drivers briefing with an inversion for the second round of heats.
- Each driver will have an inside row start and an outside row start, in the heats.
- Points attained through the heats will determine the qualifying position in the A or B-Main
- If you do not finish your heat, you do not get any heat points.
- Top 12-point scorers go direct into the A Main, 4 cars from the B Main transfer to the A Main.
- Top points scorer has choice of starting position in the A Main 16 cars to start A-Main
- To split any cars on equal points the car that has recorded the fastest lap during the heats using the transponder system, will be deemed the higher qualifier.

Simpson Speedway in consultation with the state member club for Sprintcars (SRA of Vic Inc) reserves the right to add, alter or amend the format.

(Heat events are not to have less than eight sprintcars)

**Heats 10 laps - B Main 15 laps - A Main 25 laps**

Simpson Speedway uses the AMB Transponder System for the purpose of lap scoring and timing. Hire transponders are available at a cost of \$30 incl. GST per night. Transponders not purchased through the System Operator at the venue will incur a service fee of \$15 incl. GST per night.

**NOMINATIONS for this event must be in by the no latter than Friday the 15<sup>th</sup> of January 2010** please see nomination information on the next page.

**Nominations**



Nominations are to be nominated 21 days prior to the scheduled event by the **(15/01/2010)** on the official SRA nomination form (see attachment) Nomination cost is \$50.00 Inc GST per car. It is required that if you are make payment by cheque please make out to: **(The Sprintcar Racing Association of Victoria Inc)** in full not SRA or supply credit card details on the nomination form. Faxed and posted nomination forms, accompanied with payment, must be with **Lisa Van Der Elst** within the specified time. **Postal delays are not accepted as an excuse**, please allow five working days for postal service. Phone nominations will be accepted provided full payment details are supplied at the time. **On attendance nomination fees received on time by the (15/01/2010) will be reimbursed.** Late nominations will be accepted, the nomination fee remains at \$50.00 Inc GST, but no nomination fee will be refunded to that competitor nominated. If no nomination is received within 24 hours of the race meeting commencing, then the \$50.00 nomination fee can be paid on the day of the race meeting, but the competitor will be starting rear of field in both heats. Any driver whom nominates, but fails to attend the race meeting will forfeit his/her nomination fee, there is no exceptions.

**Scrutineering will commence at 3pm till 4.30 pm** (sprintcar scrutineered after 4.30 will have rear of the field starts in all there heats)  
 All scrutineering will be conducted in a designated area at the venue.  
 All safety gear, licence and log book must be presented at scrutineering with the sprintcar. Please ensure you have ready your logbook (with SCCA license / infringement book stapled inside the front cover) and NASR license for inspection.
